- (1) Represents last day closing of Nymex Henry Hub.
- (2) Represents monthly average Belvieu and Conway pricing weighted with the Company's NGL component mix. The 2013 NGL price per gallon has been recasted to reflect impact of ethane rejection.
- (3) Represents the difference between Nymex Henry Hub and the monthly average Belvieu and Conway pricing weighted with the Company's NGL component mix converted to an MMBtu basis. The 2013 Frac Spread has been recasted to reflect impact of ethane rejection.
- (4) "Other" includes Condensate Sales, Gas Marketing activity, and other items.
- (5) "Other Income" includes gain/(loss) on asset sales, asset writeoffs and other miscellaneous items.
- (6) This volume represents equity and third party volumes transported on the Company's liquid pipeline assets and fractionated volumes associated with our 'non-operating' interest in certain facilities at Mont Belvieu. \*\* Margin consists of total operating revenues less purchases of natural gas and petroleum products, plus earnings from unconsolidated affiliates. Margin is viewed as a non-Generally Accepted Accounting Principles ("GAAP") measure under the rules of the Securities and Exchange Commission ("SEC"), but is included as a supplemental disclosure because it is a primary performance measure used by management as it represents the results of product sales versus product purchases. As an indicator of our operating performance, margin should not be considered an alternative to, or more meaningful than, net income or cash flow as determined in accordance with GAAP. Our margin may not be comparable to a similarly titled measure of another company because other entities may not calculate gross margin in the same manner.
